# AHCCCS Contractor Operations Manual (ACOM) Policy 306 CYE 2024 VBP Benchmarks

### **CYE 2024 Benchmark Setting Methodology:**

In order to establish the VBP Threshold Benchmark and the High Performing Benchmark, AHCCCS conducted a comparison of the line of business aggregate performance measure rate with the associated measure's NCQA Quality Compass percentile data. The NCQA Quality Compass percentile data were then utilized to inform the selection of an appropriate benchmark. For the CYE 2024 VBP benchmark selection, AHCCCS utilized CY 2022 line of business aggregate rates and the associated measures' 2023 NCQA Quality Compass percentile data.
