Overview



What Is Happening?

- AHCCCS was directed to pursue an <u>emergency rule</u> to support the Home and Community Based Services (HCBS) Needs Tool (HNT) pause for children under the age of 18.
- This allows AHCCCS to:
 - Revise the HNT, including the assessment categories and age limits
 - Establish an exception process (extraordinary care review)

What Does This Mean?

- An Emergency Rule is a short-term (180 day) rule in the Arizona Administrative Code that gives an agency authority to take certain actions
 □ basically like an instruction manual.
- It gives direction to AHCCCS, who then has to make sure policies follow the Rule.
- AHCCCS must follow (comply with) the Rule and make sure the health plans (including DDD) also follow the requirements.
 - AHCCCS does this through policies:
 - AHCCCS Medical Policy Manual
 - AHCCCS Contractor Operations Manual



Why Does This Matter?

- The Governor's Office and AHCCCS heard there were a lot of concerns about some of the new policies that were implemented on October 1, 2025.
- Governor Hobbs <u>directed AHCCCS</u> to pause the policies, specifically the HNT for children under 18, to create an exception process and revise the tool to make any appropriate updates.
 - This provided some relief to members, families, advocates and providers who were concerned about the policies and the impact they may have on AHCCCS members.
 - This also provides the agency and the community an opportunity to rework the policies.



What Has AHCCCS Done So Far?

- After the Emergency Rule was approved by the Secretary of State,
 AHCCCS started to meet with stakeholders to hear what should be updated, including:
 - Health plans (including DDD), parents/parent representatives, legal advocates, providers/provider advocates, I/DD experts, and community-based developmental pediatricians.
- AHCCCS has taken the feedback and drafted policies that will soon be posted for public comment.
 - Some policies, such as the HNT, have been revised.
 - One policy (the HNT Exception process) is new.





Policies



What Policies Will be Updated or Created?

- AHCCCS will post four policies for public comment:
 - 1620-17A: HCBS Needs Tool (revised)
 - 1620-17B: HNT Guidance for Child Tool (revised)
 - 1620-17C: HNT Guidance for Adult Tool (revised)
 - ACOM 450: ALTCS Extraordinary Care Review Process for Minor Members (new); will also include an attachment
- In order to meet the requirements of the Rule and state law, policies will be open for an expedited public comment period.
 - This means that they will be posted for 14 days to review and provide feedback on.

What Happens After This?

- Policies are expected to post for public comment on Monday, November 10.
 - Policies will be open for public comment through Monday, November
 24.
- AHCCCS will continue to engage with the community \(\Delta\) we want to hear from you and would welcome ideas on how you would like this to happen and how often you want this to happen?

What Happens with the Emergency Rule?

- The Emergency Rule is valid for 180 days (until April 13, 2026).
- AHCCCS will need to pursue Regular Rulemaking.
 - A Regular Rule is a permanent rule in the Arizona Administrative Code.
 Regular Rules are not time limited but are reviewed every five years to make sure they are still needed.
 - This means that AHCCCS will have to look at the Emergency Rule, figure out any needed changes, and then go through the Rulemaking process.
- Regular Rulemaking has several steps:
 - Key steps include informal feedback, an economic impact study, formal public comment, a hearing at AHCCCS, a presentation and hearing with the Governor's Regulatory Review Council, and approval by the Secretary of State.

What do I Need to Know About Regular Rulemaking?

- Rules are mainly for agency purposes \square but they are important to be aware of as they can impact how health plans (including DDD) provide services to members.
- AHCCCS will begin working on the Regular Rulemaking after policies close for public comment and all the feedback is reviewed.
- AHCCCS will seek feedback on the Rule in several ways:
 - Public forums (not yet scheduled)
 - Stakeholder workgroups
 - Public Comment

- Early December: AHCCCS finalizes Policies and starts to work on Regular Rulemaking
- December

 Early January: AHCCCS gets feedback on draft Regular Rule
- Early January: Final policies are implemented (starts using the new HNT)
- Early January: Health plans (including DDD) finalize/implement their Exception process
- Early February: Regular Rule presented to GRRC
- February: Regular Rule is finalized and signed
