


SMI Eligibility Determinations FAQ

- Q1: How many SMI Eligibility Determinations were completed, approved, and denied in 2019, 2020, and 2021?
- Q2: How does the volume of SMI Eligibility Determinations compare to year over year?

Q1: How many SMI Eligibility Determinations were completed, approved, and denied in 2019, 2020, and 2021?



Q2: How does the volume of SMI Eligibility Determinations compare to year over year?

A2: The volume of SMI Eligibility Determinations experienced an approximated 9.06 percent decline in volume between 2019 and 2020, and an approximated 2.75 percent decline in volume between 2020 and 2021. On average, the volume of SMI Eligibility Determinations, compared year over year, continues to decline.

Q3: How many of the total volume of SMI Eligibility Determinations initiated in a hospital?

- A3: The number of SMI Eligibility Determinations that began when the individual was inpatient for the years 2019, 2020, and 2021 are listed below:
 - 2019 = 3606
 - 2020 = 3888
 - 2021 = 4057



- Q4: What are the practices and education provided regarding SMI Eligibility Determinations and splitting out Substance Use Disorder (SUD) from the diagnosis?
- A4: Solari regularly conducts the following training sessions to support education regarding performing an SMI Eligibility Determination. SMI Determination Training Sessions have a general focus, while the SMI Clinical Training Sessions have an assessment focus. SMI Eligibility Determination practices/education and splitting out SUD from the diagnosis are topics covered in the trainings.

SMI Eligibility Determination Training sessions are held on: The first Monday of each month from 9:00 AM – 10:30 AM The second Friday of each month from 10:00 AM – 11:30 AM The third Monday of each month from Noon – 1:30 PM The fourth Friday of each month from 2:00 PM – 3:30 PM No session will be held if day falls on a holiday

SMI Clinical Training session is held on:

• The third Thursday of each month from 9:00 AM – 10:00 AM
