Re: FY2022 Original Allocation Schedule

Original FY2022 Allocation Schedule:

The Allocation Schedule for this fiscal year reflects the Tribal and Regional Behavioral Health Authorities contracted amounts for SFY2022 ending June 30, 2022. The Allocation Schedule for this fiscal year reflects the following changes that have occurred in funding of Arizona's public behavioral health system. Some of the changes include:

- Continuation of the balance of the SFY2021 Children's Behavioral Health funds, in accordance with the requirements included in A.R.S. §36-3436.
- Housing allocations are subject to change based on final approved spending plans.
- Flex funds continue to be permanently eliminated, with the exception of specific approved allocations for Opioid Grant Funding.
- Continuation of the allocation of Non-TXIX SMI services funding to the RBHAs for ALTCS members.
- Substance Use Disorder Fund (SUDS) allocated to AHCCCS per Laws 2020 1st Regular Session Chapter 408
- Federal funds cannot be utilized directly or indirectly to purchase, prescribe, or provide marijuana or treatment using marijuana, per 45 C.F.R. §75.300(a); 21 U.S.C. §§ 812(c) (10) and 841.
- Continuation of funding from the SABG Block Grant to support the use of Medication Assisted Treatment (MAT) to SABG eligible behavioral health recipients.
- Continuation of funding from the SABG Block Grant for Crisis, Children, & Oxford House in General Services.
- Continuation of SABG Block Grant to target families with children at risk of removal by the Department of Child Safety (DCS).

- Continuation of SABG Block Grant funding for Child Care in accordance with guidance provided by AHCCCS.
- Continuation of MHBG Block Grant to target SED funding for families with SED children at risk of removal by DCS.
- Continuation of MHBG Block Grant funds for First Episode Psychosis (FEP) and Early Serious Mental Illness (ESMI) programs, subject to written approval from AHCCCS.

Specific Instructions:

- Any deviation that a RBHA or TRBHA may want to make between funding categories (e.g., between SABG or MHBG categories, etc.) on the allocation schedule (or payment schedule) must have prior written approval from AHCCCS.
- Please note AHCCCS will not provide interim financing for the FFY 2022 SABG Block Grant or the FFY2022 MHBG Block Grant from General Fund sources in SFY2022. Disbursements will occur upon receipt of the Notice of Grant Award from the Department of Health and Human Services, Substance Abuse and Mental Health Services Administration (SAMHSA).
- 3. Non-Title XIX/XXI revenue is to be accrued using 1/12th of the annual allocation as reported on the AHCCCS Allocation Schedule, with the exception of FFY2022 Block Grants beginning 10/1/2021 or as indicated in the detailed footnotes. Revisions to the allocation may occur throughout the year, but until the RBHAs or TRBHAs are notified in writing of any changes, the amount reported on the Allocation Schedule (or payment schedule, if appropriate) is the best and most probable estimate of what AHCCCS will pay out. Prior written approval must be obtained from AHCCCS for any deviations from the AHCCCS Allocation Schedule or Pay Schedule.
- 4. MHBG and SABG Block awards are subject to the Federal Funding Accountability & Transparency Act (FFATA). Instructions and forms for this requirement can be found on the AHCCCS website at https://www.azahcccs.gov/Resources/Grants/FFATA/. Please complete the forms within 15 days of receipt of this letter.
- 5. Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) and American Rescue Plan Act (ARPA) funding for both MHBG and SABG have been included in the SFY22 Allocation Schedule. Specific allocation amounts of the CRRSAA and ARPA funding will be delineated in a future allocation letter to the RBHAs and TRBHAs receiving these specific funds.
