Offeror discussed expansion of the network beyond MSIC providers and described its process for determining whether an MSIC or non-MSIC is appropriate for the member.

Offeror addressed provision of behavioral health services both in the MSIC and through non-MSIC providers.

Offeror has contracts in place with a broad network, including 638 tribal providers, and is undertaking a field clinic expansion.

Offeror has arranged for PCPs to be onsite at the Phoenix-area MSIC.

Offeror described use of field clinics and telemedicine for providing access to rare pediatric subspecialties.

Offeror has created a patient registry to facilitate information sharing among providers.

Offeror has committed to offering 24-hour and mail order pharmacy services.

Offeror committed to expanding relationships with non-MSIC providers but did not provide details on the number of LOIs or contracts secured to date.

Offeror addressed provision of behavioral health services both in the MSIC and through non-MSIC providers.

Offeror committed to permitting out-of-network care for 180 days after enrollment, followed by single case agreements in situations where the member wishes to continue care with the provider and the provider is unwilling to join the network.

Offeror addressed contracting with MSICs but did not discuss in detail the importance of MSIC providers within the care system for CRS members.
