## NAME CHANGE

Effective April 1, 2021, Comprehensive Medical and Dental Program (CMDP) changed to Comprehensive Health Plan (CHP) due to Behavioral health integration. Refer to Laws 2019, 1<sup>st</sup> Regular Session. AHCCCS is in the process of revising all pertinent documents to reflect the new name.

# **CONTRACT NAME CHANGE**

Effective October 1, 2022, the Regional Behavioral Health Authority (RBHA) for the Managed Care Organizations was aligned with the Competitive Contract Expansion YH20-0002 to expand the provision of services for the awarded ACC-RBHA Contractors. AHCCCS is in the process of revising all pertinent documents to reflect this change.

Attachment A was revised to switch administrative component and case management component under capitation. Net capitation has been expanded to include all components in the description. Covid vaccine administration assumption was revised to add Contract Year 24. Pharmacy Benefit assumption was deleted, as this was only valid for Contract Year End 2020. *Implementation Date 10/01/23.* 

#### ACOM POLICY 311 - ACC AND ACC-RBHA PROGRAM TIERED RECONCILIATION

ACOM Policy 311 was revised to align with annual updates including adding dates for Contract Year End (CYE) 24 and minor formatting. Added clarification due to concern about the unwinding of the Public Health Emergency (PHE). Period has been changed to Contract Year for consistency throughout policy.. *Implementation Date 10/01/23*
