## **Filled FTE Positions**

Pursuant to Laws 2025, Chapter 233, Section 141, AHCCCS is providing the following report of filled, appropriated, and non-appropriated full-time equivalent (FTE) positions by fund source.

As of September 2025, AHCCCS had 1,239.6 filled positions out of 1,274.5 appropriated positions. This includes 70.3 filled non-appropriated positions that relate to the Hawaii Arizona PMMIS Alliance (HAPA) and federal grants. A breakdown by fund source and program is provided below:

Other Appropriated Funds include 19.5 FTE from the CHIP Fund Title XXI program in the Operating Lump Sum Appropriation, 4.1 FTE from the Health Care Investment Fund (HCIF) in the Operating Lump Sum Appropriation, 1.9 FTE from the SMI Housing Trust Fund in the Operating Lump Sum Appropriation, and 0.4 FTE from the Prescription Drug Rebate Fund in the Operating Lump Sum Appropriation.

The filled positions above represent those positions within the AHCCCS appropriation for which AHCCCS has managerial control. Another 1,184.8 FTE are passed through to the Arizona Department of Economic Security. AHCCCS management does not receive information pertaining to the status of these positions.
